**Subject:-** Grant of NOC for the new courses w.e.f the academic session 2021-22.


In reference to your letter No. 607 dated 1.2.2021 on the subject cited above.

I have been directed to inform you that the State Government has granted NOC for the following new courses proposed to be started by your University as per the details given below:-

1. B.Sc in Para Medical Sciences Medical Lab Technology (MLT); Anaesthesia & Operation Theatre Technology (AOTT); Medical Imaging Technology (MLT) Dialysis Therapy Technology (DTT); etc. In the case of exercising exit option by students after 2 Years Advanced Diploma in respective specializations MLT, AOTT, MIT, DTE etc
2. M.Sc Science e.g. Chemistry, Physics, Agriculture Science, Horticulture, etc.
3. Ph.D in Agriculture

**The approval shall be subject to the following conditions:-**

1. The eligibility criterion for admission to undergraduate and post graduate programmes, number of seats in each programme/course and the duration of courses should be in line with the norms and regulations of UGC and other regulatory authorities.
2. The faculty to be engaged should be well qualified, and as per UGC norms and regulations.
3. The number of faculty members to be engaged shall also be in accordance with the UGC guidelines/ norms and these details must be prominently displayed on the website of the University.
4. The University shall have tie ups with Medical Centres, Hospitals etc for Para Medical Students internships, faculty and practice. The University shall enter into agreement with such hospitals for the mentioned purpose.
5. Requisite approvals of all concerned regulatory bodies shall be taken by the University before starting the new courses.
6. UGC Guidelines regarding nomenclature of the courses shall be adhered to in letter and spirit.
7. The University shall adhere to the provisions of Government of India Act on paramedical Sciences.


In reference to your letter No. JNUB/REG/55 dated 23.6.2021 on the subject cited above.
